RENUMBERING LOCAL LAW NO. 3 OF 2025 TO REMOVE EXEMPTION UNDER NEW YORK STATE REAL PROPERTY LAW SECTION 487 FOR SOLAR, WIND AND FARM WASTE ENERGY SYSTEMS WITHIN THE TOWN OF SOUTHPORT, TO LOCAL LAW NO. 2 OF 2025

WHEREAS, the Town of Southport Town Board enacted Local Law No. 3 of 2025 To Remove Exemption Under New York State Real Property Law Section 487 For Solar, Wind and Farm Waste Energy Systems Within the Town of Southport at the Town Board meeting held on February 11, 2025; and

WHEREAS, at said meeting the Town Board was also considering the enacting another local law numbered as local law number 2; however, the local law numbered as 2 was not enacted at such time; therefore, to allow for proper numbering and filing of Local Law No. 3 of 2025 To Remove Exemption Under New York State Real Property Law Section 487 For Solar, Wind and Farm Waste Energy Systems Within the Town of Southport, the Town Board must approve the renumbering of this local law to Local Law No. 2; and

NOW THEREFORE BE IT RESOLVED, that Local Law No. 3 of 2025 To Remove Exemption Under New York State Real Property Law Section 487 For Solar, Wind and Farm Waste Energy Systems Within the Town of Southport which was enacted by the Town of Southport Town Board on February 11, 2025 be hereby renumbered and titled as Local Law No. 2 of 2025 To Remove Exemption Under New York State Real Property Law Section 487 For Solar, Wind and Farm Waste Energy Systems Within the Town of Southport.

RESOLVED, that the Town Board of the Town of Southport, County of Chemung, State of New York hereby adopts Local Law No. 2 of 2025, To Remove Exemption Under New York State Real Property Law Section 487 for Solar, Wind and Farm Waste Energy Systems Within the Town of Southport, and is hereby enacted to wit:

Local Law No. 2 of 2025 To Remove Exemption Under New York State Real Property Law Section 487 For Solar, Wind and Farm Waste Energy Systems Within the Town of Southport

#### Section 1. Title.

This local law shall be known as "Local Law No. 2 of 2025 To Remove Exemption Under New York State Real Property Law Section 487 For Solar, Wind and Farm Waste Energy Systems Within the Town of Southport".

#### <u>Section 2.</u> Legislative Intent.

It is the intent of this local law to allow the Town of Southport to opt out of the New York State Real Property Tax Law (RPTL) Section 487, thereby to remove an exemption for taxation in accordance with New York State RPTL Section 487 for any solar, wind and farm waste energy systems within the Town of Southport.

## Section 3. Authority.

This local law is adopted pursuant to New York State Real Property Tax Law Section 487-8(a) which expressly authorizes a Town by local law to provide that no exemption under New York State RPTL 487 shall be applicable within its jurisdiction with respect to any solar, wind, or farm waste energy system which began construction subsequent the effective date of such local law, whichever is later.

# Section 4. Inconsistent Laws.

All laws inconsistent with any provision or provisions of this law are hereby repealed.

## Section 5. Severability.

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

<u>Section 6.</u> Effective Date. This local law shall take effect immediately upon filing with the Secretary of State, New York State Department of Taxation and Finance and New York State Energy Research and Development Authority (NYSERDA).
